Year in Review

This year RTAP made a major effort to encourage peer to peer collaboration with the introduction of the monthly peer roundtable series. One of the outcomes of this group was a multi-agency collaboration to create a series of detailed resources around Incident/Accident response best practices, presented at the Spring Workshop. Other highlights from the year include:

- 20 agencies trained their drivers online, with over 225 course registrations.
- 4 intensive dispatching & scheduling trainings around the state.
- In-person train-the-trainer courses for both Recognizing & Reporting Abuse and Defensive Driving
- 25% increase in the number of drivers and other staff completing online courses over last year.
- 73% increase in scholarship funds awarded.
- All FTA section 5311 funded transit agencies participated in RTAP training in one form or another.

We look forward to serving the Greater Minnesota transit community in the year to come and invite your feedback and participation!




